# **Housing Counseling Program**

## What is a Housing Counselor?

Housing Counselors are the backbone of our agency's primary service. They work directly with our clients, educating tenants and landlords about their rental rights and responsibilities, small claims court procedures, and giving referrals to agencies that can provide additional assistance.

This challenging work is highly rewarding! You might help a low-income family avoid eviction, or help a landlord ensure they are following fair housing laws in their rental applications. This position is ideal for anyone wishing to have an immediate, positive influence in their community and help people with solutions to real life problems. Many Housing Counselors are students, activists, law or real estate professionals. Others are apartment managers, social workers, people working for social and economic justice, and anti-discrimination workers.

#### **Training and Requirements**

Housing Counselors must complete a 12-hour training session on local, state, and federal housing laws. These are taught by our staff several times a year. This training is followed by an additional 4 - 8 hours shadowing an experienced counselor while they work with clients. Staff are available to supervise and answer questions. Housing Counselors are asked for a minimum commitment of 3 hours per week for one year, scheduled during our regular office hours. UW Madison Pro Bono Legal Program is available for law students, and professional references are available for anyone building their resume.

# **Housing Mediation Service**

#### What is a Mediator?

The volunteers who staff the Housing Mediation Service are trained in mediation. We provide further training in small claims court mediation and Tenant Resource Center procedures. By acting as a neutral third party to a rental dispute, they help clients find a mutually agreeable resolution to their housing problems, such as avoiding eviction.

Most mediations take place at the Dane County Courthouse on Tuesdays during eviction hearings. Mediators help tenants and landlords come to an agreement to avoid an eviction trial, usually a payment plan or a move-out date. There are also mediation sessions scheduled at our main office for disputes between tenants, landlords, roommates, and neighbors, including evictions with no pending court case.

This position is ideal for trained, professional mediators who wish to practice or gain experience in small claims court mediation. The Housing Mediation Service can offer volunteers 3 - 8 hours of mediation each month.

#### **Training and Requirements**

Volunteers must have completed outside training in out-of-court mediation and be available for regular shifts at the courthouse (8am - 12pm and/or 1pm - 4pm on Tuesdays). We ask for a minimum commitment of at least one shift a month for one year.

New mediators will receive 9-12 hours of shadowing and supervision at the courthouse before leading sessions on their own. They will also receive basic training on eviction laws, Dane County small claims court procedures, how to collect client demographic information for our funding, and how to refer clients to other programs.
